Marjorie grew up and went to school in Brownsville. Her family moved to Compton, California where she finished high school and graduated from Compton College. Marjorie married Wesley Niemann on March 29, 1952 in California. She began working in banks in California and worked 50 years for US Bank. They moved to Oregon and she became the manager at the US Bank in Hillsboro. Wesley Niemann preceded her in death in 1962. Marjorie married Robert Ficken and they made their home in Hillsboro and then moved to Sherwood. She was a member of St. Paul Lutheran Church in Sherwood. Marjorie was active in their youth programs and served as financial secretary for the church. She loved growing flowers and doing quilting. On Monday, May 2, 2011 Marjorie June Ficken died at a local hospital when she was seventy-eight years, eleven months and twenty-seven days of age.
