On July 10, 2010, a wonderful, loving man went to heaven. Steve was born May 9, 1972 in Nigeria, West Africa to John and Bonnie Newman, translators with Wycliffe Bible Translators. He learned the local language and had Nigerian friends. He was educated in Newberg, Oregon, Sudan and Kenya. He graduated from Newberg High School in 1990, Oregon State University in 1994, and Northwestern School of Law, Lewis and Clark in 1997. He practiced law on the island of Saipan as a law clerk and then as legal counsel to the governor from 1999 to 2008. In 2003 he and Olive Malet were married in Saipan. In 2008 they moved to Guam where he worked as Assistant Attorney General for Civil Affairs. Steve enjoyed family, playing golf, and running marathons. He and Olive attended St. Anthony Catholic Church. Steve is survived by his wife Olive, his parents, John and Bonnie of Newberg; his sister Beth Newman of Newberg; his brother Dan Newman of Newberg; many nieces, nephews, aunts and uncles, and those who have come to know and appreciate him where he has lived and worked. His Memorial Service will be Saturday, July 17, 2010 at 1:00 p.m. in Attrell's Newberg Funeral Chapel, a Golden Rule Funeral Home, with Pastor Dick Sartwell officiating. “ Dear Mr. and Mrs. Newman: I would like to express my condolences to you and your family on the death of Steve. He was a good and humble man and I have a lot of respect for him. I was close to him. I will miss him. I worked for Steve as a legal assistant during Governor Babauta's Administration here on Saipan and further worked with him after he had left the government as associate counsel for the law firm of former Judge Edward Manibusan on the Commonwealth Utilities Corporation matters. Steve and I communicated by phone, text and e-mail three consecutive days just before he left Guam on July 5th. His first contact was 3:30 a.m. on July 1st by text. He told me that he was out sick for three days; he will have a conference call at 5:00 a.m. that morning and asked that I call him at 8:00 a.m. on same day. So I did and we talked. Subsequently, he text, e-mailed and called several times for the next three days before his departure. One of the things he mentioned to me on Saturday night, July 3rd (our last communication) was that if he dies, he wanted to be buried in Africa because he was born and raised there. He has always told me that when I was working for him. He told me that he's close to his African nanny. Mr. and Mrs. Newman, I am really sorry for expressing my condolences late but I still could not believe that Steve is gone.
